1 Consent

2 Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for a free Bondix S.A.NE 7-day trial, we may ask for your contact information, including but not limited to items such as name, company name, email address, and country.

3 How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website;
- Improve, personalize, and expand our website;
- Understand and analyze how you use our website;
- Develop new products, services, features, and functionality;

4 Log Files

SIMA GmbH follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this as a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.
